



RESOLUTION NO. 2026-087

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, APPROVING, REAFFIRMING AND RATIFYING PAYMENT OF COSTS TO DALLAS COUNTY, TEXAS, FOR CONDUCTING AND THE ADMINISTRATION OF THE RUNOFF ELECTION HELD ON SATURDAY, JUNE 13, 2026, IN ACCORDANCE WITH THE JOINT ELECTION SERVICES CONTRACT WITH DALLAS COUNTY, IN AN AMOUNT NOT TO EXCEED \$135,050.93; AUTHORIZING THE CITY MANAGER TO PROVIDE FOR PAYMENT ON THE CITY'S BEHALF; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council has called for a runoff election to be held on June 13, 2026, for the election of a Mayor; and

WHEREAS, the City has approved a Joint Election Services Contract, whereby the election was administered by the Dallas County Elections Department, which contract is the form election services agreement between Dallas County and all participating political subdivisions conducting elections on the May 2026 uniform election date and the June 13, 2026, uniform runoff election date; and

WHEREAS, the Election Services Contract provides that the Dallas County Elections Administrator will coordinate, supervise, and handle all aspects of administering the runoff election, as a Joint Runoff Election among the participating cities and political subdivisions, in accordance with the provisions of the Texas Election Code and as outlined in the Election Services Contract, and that all participating cities shall remit payment to Dallas County for proportionate costs associated therewith, which for the City of Farmers Branch is the sum of \$135,050.93; and

WHEREAS, the City Council finds and determines that it is in the public interest to approve, reaffirm and ratify payment in accordance with the Election Services Contract between the City and Dallas County.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS THAT:

SECTION 1. The City Council hereby approves, reaffirms and ratifies payment to Dallas County for the City's proportionate share of costs for the County's administration and conduct of the June 2026 runoff election in Farmers Branch in an amount not to exceed \$135,050.93 and does further authorize the City Manager to provide for payment for the election administration services for said election.

SECTION 2. This resolution shall become effective immediately from and after its passage.
