Conduct a public hearing and consider the request to amend Article 5 "Special Districts" of the Comprehensive Zoning Ordinance by amending Article 5.6 "Alcoholic Beverage (On-Premise) Overlay Districts" to add the Spring Valley Alcoholic Beverage (On-Premise) Overlay District, an approximately 7.96-acre property located at 4801 Spring Valley Road and located within the Planned Development District No. 27 (PD-27) zoning district; and take appropriate action.
