



**ORDINANCE NO. 3256**

**AN ORDINANCE OF THE CITY OF FARMERS BRANCH, TEXAS, AMENDING THE CODE OF ORDINANCES, CHAPTER 82 “TRAFFIC AND VEHICLES”, ARTICLE II “OPERATION OF VEHICLES”, DIVISION 6 “PARKING”, SECTION 82-95 “NO PARKING ZONES” BY REPEALING THE NO PARKING ZONES ON GOLFING GREEN DRIVE ESTABLISHED BY ORDINANCE NO. 3168; ESTABLISHING NO PARKING ZONES ON PORTIONS OF GOLFING GREEN DRIVE NORTH OF ITS EAST INTERSECTION WITH BROOKHAVEN CLUB DRIVE; ESTABLISHING NO PARKING ZONES ON PORTIONS OF DENNIS LANE NORTH OF LONGMEADE DRIVE; CONTAINING A SAVINGS CLAUSE; CONTAINING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY OF FINE NOT TO EXCEED \$200; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City Administration, in order to increase the safety of the movement of traffic along the public thoroughfares of the City of Farmers Branch, is recommending elimination of no parking zones on Golfing Green Drive established pursuant to Ordinance No. 3168, establishing no parking zones along other portions of Golfing Green Drive; and establishing no parking zones along portions of Dennis Lane; and

**WHEREAS**, the City Council of the City of Farmers Branch, Texas, finds it to be in the public interest to amend the Code of Ordinances of the City of Farmers Branch to concur in the foregoing recommendation;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:**

**SECTION 1.** Code of Ordinances, Chapter 82, “Traffic and Vehicles,” Article II, “Operation of Vehicles,” Division 6, “Parking,” Section 82-95, “No Parking Zones,” is amended by deleting and repealing the No Parking Zones along the following portions of Golfing Green Drive enacted pursuant to Ordinance No. 3168:

<i>Street:</i>	<i>Description</i>	<i>Time of Day</i>
Golfing Green Drive	Either side, from 265 feet east of the intersection with Webb Chapel to 415 feet east of the intersection with Webb Chapel.	All times
Golfing Green Drive	Either side, from 468 feet west of the intersection with Brookhaven Club Drive to 618 feet west of the intersection with Brookhaven Club Drive.	All times

**SECTION 2.** Code of Ordinances, Chapter 82, “Traffic and Vehicles,” Article II, “Operation of Vehicles,” Division 6, “Parking,” Section 82-95, “No Parking Zones,” is amended by adding the following No Parking Zones along the following portions of Golfing Green Drive and Dennis Lane for the time(s) of day indicated:

<i>Street:</i>	<i>Description</i>	<i>Time of Day</i>
Golfing Green Drive	East side from approximately 287 feet north of the north curb of its east intersection with Brookhaven Club Drive to approximately 540 feet north of the intersection of Brookhaven Club Drive.	All times
Golfing Green Drive	West side from approximately 295 feet north of the north curb from its west intersection of Brookhaven Club Drive to approximately 518 feet north of the intersection of Brookhaven Club Drive.	All times
Dennis Lane	East side from approximately 50 feet north of the north curb of its east intersection of Longmeade Drive.	All times
Dennis Lane	East side from approximately 220 feet north of the north curb of its east intersection of Longmeade Drive to approximately 340 feet north of the intersection of Longmeade Drive.	All times
Dennis Lane	East side from approximately 443 feet north of the north curb of its east intersection of Longmeade Drive to approximately 564 feet north of the intersection of Longmeade Drive.	All times

**SECTION 3.** Appropriate signs prohibiting parking at the places and during the times consistent with this Ordinance shall be installed and maintained by City forces.

**SECTION 4.** Any person violating any provision of this ordinance shall be deemed guilty of a misdemeanor and upon conviction shall be fined a sum not to exceed TWO HUNDRED DOLLARS (\$200.00).

**SECTION 5.** An offense committed before the effective date of this ordinance is governed by prior law and the provisions of the Code of Ordinances, as amended, in effect when the offense was committed and the former law is continued in effect for this purpose.

**SECTION 6.** If any section, paragraph, subdivision, clause, phrase or provision of this ordinance shall be judged to be invalid or unconstitutional by a court of competent jurisdiction, the same shall not affect the validity of this ordinance as a whole or any portion thereof other than the portion so decided to be invalid or unconstitutional.

**SECTION 7.** This ordinance shall take effect from and after its passage and the publication of the caption of said ordinance as the law and the City Charter in such cases provides.
