C. <u>AGENDA ITEMS</u>

C.1 Receive a presentation from Ally's Director of Workplace Sustainability

Eoin Fitzgerald, Ally Financial's Director of Workplace Sustainability provided a presentation of corporate sustainability initiatives at their office in Lewisville. The construction is targeting LEED certification and has incorporated many environmentally friendly attributes. The installation of new HVAC units are 25% more energy efficient and require less maintenance. The parking lot will also feature EV chargers and 1.25 MW of solar panels which provide shade protection for 300 parking spots.

Eoin also went into detail about the centralized trash and composting pilot at the Charlotte, NC headquarters. The headquarters removed individual trash cans and placed central receptacles with trash, compost, and recycling bins. As a result, the diversion from the landfill increased and they reduced the number of plastic trash bags used.

C.2 Consider approving minutes for the May 8, 2024 meeting; and take appropriate action

Shelby Anders made a motion to approve the minutes. The motion was seconded by Loren Rives. All in favor. Motion carried.

C.3 Receive a staff update on sustainability initiatives

- Farmers Branch was accepted into the Texas Accelerator program for the LEED for Cities certification program
- Staff are finalizing the quote with the contractor for the LED light retrofit at the recreation center parking lot. This is a grant funded project.
- The city's use of funding for the Department of Energy's EECBG grants was approved. The city will use these funds for the purchase of two electric vehicles.
- Staff are working on the SolSmart Designation, which aims to reduce barriers to adopting solar.
- Parks department staff are looking into grow zones and pollinator areas. Staff met with the City of Plano to identify best practices.
- Water Rebates 88 toilet rebates and 5 irrigation check-up applications have been approved since the program has launched.
