- D.2 24-ZA-20 Conduct a public hearing and consider the request to rezone approximately 2.12 acres of property located at 14500 Landmark Boulevard, described as Lot 4, Block 1, Wellington Square Addition, from Light Industrial (LI) zoning district to Planned Development District No. 109 (PD-109) zoning district, including creation of PD-109, to allow multi-family residential development and establish related development standards; and take appropriate action
