C. <u>PUBLIC HEARING</u>

C.1 Conduct a public hearing and consider adopting Ordinance No. 3242 approving a Specific Use Permit allowing a detached accessory building greater than 120 square feet in area, located at 3320 Rockmartin Drive, and within the One Family Residential District 1 (R-1) and take appropriate action. Andy Gillies gave a brief presentation regarding the request. He stated the new property owners were in the process of renovations to the clubhouse area, an approximate 136 square foot addition, that required a specific use permit.

Terry Moore, 14860 Montfort, Dallas, representing the applicant, was available for questions.

Mr. Gillies stated that 12 notices were mailed to surrounding property owners. City staff received one response in favor.

Chairman Patterson opened the public hearing and asked if anyone wanted to speak regarding the request. There being none, the public hearing was closed.
