A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, AUTHORIZING AN AGREEMENT WITH STRYKER PROCARE SERVICE FOR MAINTENANCE OF STRYKER MEDICAL EQUIPMENT IN AN AMOUNT NOT TO EXCEED \$59,848.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in FY 2025-2026, the Fire Department budgeted \$59,848.00 for Stryker ProCare Services to provide annual maintenance for Stryker equipment already in the City's possession; and

**WHEREAS**, this represents an increase over FY 2024-2025 resulting from equipment exceeding its one-year warranty; and

WHEREAS, City Administration recommends authorizing an agreement with Stryker ProCare Service to provide the City with maintenance for Stryker medical equipment used by the Fire Department, attached hereto as Exhibit "A"; and

WHEREAS, the City Council of the City of Farmers Branch, Texas finds it to be in the public interest to approve the recommendation of the City Administration.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

**SECTION 1.** The City Council of the City of Farmers Branch hereby authorizes an agreement with Stryker ProCare Service for maintenance of Stryker medical equipment in the amount of \$59,848.00, attached hereto as Exhibit "A", and does further authorize the City Manager to negotiate and execute on behalf of the City all necessary contract documents and, subject to available funding, to execute any change orders, renewal options, amendments, or other instruments related thereto.

**SECTION 2.** This Resolution shall become effective immediately from and after its passage.
