CALL TO ORDER - STUDY SESSION (4 P.M.)

Mayor Lynne called the meeting to order at 4:00 p.m.

PUBLIC COMMENTS ON STUDY SESSION ITEMS

There were no members of the public wishing to address the Council.

STUDY SESSION ITEMS

A.1 Discuss regular agenda items.

Councilmember Neal had questions on Item J.7 related to an ordinance on regulations pertaining to fats, oils, and grease, Item J.11 related to the purchase of a pavement analysis and management system, and J.12 related to a payment for emergency repairs to fire apparatus.

A.2 Receive a report from City staff regarding an alternate Citizens Collection Station location, operational plan, and adding additional household hazardous waste events.

Deputy Director of Public Works Shane Davis gave a presentation explaining the history of the Citizen's Collection Station and the Household Hazardous Waste Program, the budget impact with the closing and potential reopening of the Citizen's Collection Station and of the Household Hazardous Waste Program, regulations of both programs, and the proposed new location for the Citizen's Collection Station.

Councilmember Neal requested there be a composting option for residents.

Mayor Pro Tem Roman suggested having an addition event for Household Hazardous Waste and track attendance to determine the need.

Deputy Mayor Pro Tem Jackson suggested working with the Community Garden for the composting portion.

A.3 Discuss the addition of restricted prior service credit to the City's offering under the Texas Municipal Retirement System (TMRS).

Director of Human Resources Jeffrey Ross gave a presentation explaining the purpose of having Restricted Prior Service Credit, the definition of Restricted Prior Service Credit, the current retirement benefits offered by the City, a comparison with neighboring cities, the benefits of offering Restricted Prior Service Credit to employees, and the next steps in the process.

The majority of the Council was in favor of adopting an ordinance approving the Restricted Prior Service Credit benefit for employees.

A.4 Discuss the City's Mission, Vision, and Values, and seek the City Council's direction on the next steps.

Director of Human Resources Jeffrey Ross gave a presentation on the current mission of the City and the history of changes, what an effective mission statement should consist of, the definition of core values, the survey results of the core values City employees find most important, and the definition of workplace culture.

Mayor Pro Tem Roman suggested having a consultant survey the City employees to have a clear understanding of what the employees value.

Councilwoman Bennett-Burton requested conversations gathering information from the employees occur prior to the Strategic Planning Session.

Deputy Mayor Pro Tem Jackson suggested staying with the "REACT" culture of the city and work on the definitions of those values.

The Mayor recessed into Executive Session at 5:03 p.m.

Director of Community Services Danielle Summers gave a presentation on this item explaining the current ordinance on permit time limits, the process for extension requests, and the purpose of the delay.

STUDY SESSION

A.5 Discuss Parking at the Venue 1842 Event Center and Historical Park.

A.6 Discuss and review Venue 1842.

Mayor Lynne announced that Items A.5 and A.6 would be discussed together.

Director of Economic Development, Planning, and Tourism gave a presentation explaining the history of the Venue, the break-even analysis, and options for alteration of parking.

Councilwoman Bennett-Burton requested to convene into Executive Session on this item for the purpose of seeking legal advice from the City Attorney allowable per Section 551.071 of the Local Government Code. The Council convened in Executive Session at 7:00 p.m.

Mayor reconvened the regular meeting at 7:10 p.m.

The majority of the Council directed that Venue 1842 be used as an amenity with some improvements to the acoustics and that any additional parking space should be an enhancement of the existing parking with minimal grass and tree loss.

A.7 Discuss target areas for residential redevelopment and the Demolition/Rebuild program.

Director of Economic Development, Planning, and Tourism gave a presentation explaining the current program, a comparison of neighboring cities' programs, and options for alterations to the program.

It was determined that this item be brought back after the legal team performs research on the Fair Housing Act and information gathered on the current program participants and the return on investment.

A.8 Review and discuss future agenda items.

Mayor Pro Tem Roman requested a Study Session item on giving direction to boards and commissions, an item on implementing a program for an incentive for residents who construct semipermeable driveways in areas that are highly congested, a discussion item on a calendar of celebrated holidays that accompany a proclamation, and a discussion on speaker policies.

Councilwoman Bennett-Burton requested an item for the Dallas County Appraisal District to come and give a presentation and answer questions from residents regarding property values.

Mayor Lynne requested an item on drive-throughs in the Mustang Station area and also requested having a discussion item on direction for boards and commissions.
