CALL TO ORDER - STUDY SESSION (4 P.M.)

Mayor Lynne called the meeting to order at 4:00 p.m.

C.1 Review and discuss Consent and Regular agenda items.

Councilmember Neal had questions on Item J.4 related to the Residential Demolition/Rebuild Program incentive agreement for 3333 Arawak Place and J.5 related to the Residential Demolition/Rebuild Program incentive agreement for 14621 Cherry Hills Drive.

Director of Parks and Recreation Rob Diaz gave a presentation explaining the background of the Mercer Park project, the current status of the project, the proposed phasing plans, and the cost estimate of the project.


TAKE ANY ACTION AS A RESULT OF EXECUTIVE SESSION
