## **RESOLUTION NO. 2025-242**



A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, APPROVING AN AMENDMENT TO THE LANDFILL GAS PURCHASE AGREEMENT ENTERED INTO WITH WM RENEWABLE ENERGY, LLC, FOR A MONTH-TO-MONTH TERM; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE THE SAME; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, on September 30, 2009, the City entered into a Landfill Gas Purchase Agreement with WM Renewable Energy, LLC ("WMRE"), whereby WMRE agreed to purchase, and the City agreed to sell landfill gas produced at the City's Camelot Landfill; and

**WHEREAS**, the Landfill Gas Purchase Agreement provided for an initial 15-year term after the beginning of commercially viable landfill gas production, and this term is approaching expiration; and

**WHEREAS**, the City and WMRE desire to continue the Landfill Gas Purchase Agreement on a month-to-month basis to allow for greater flexibility, while continuing the remaining requirements and obligations of the agreement; and

**WHEREAS**, the City's Public Works Department has prepared the form of an amendment to the Landfill Gas Purchase Agreement, which is attached hereto as Exhibit "A"; and

**WHEREAS**, the City Council of the City of Farmers Branch, Texas, finds it to be in the public interest to approve the amendment of the Landfill Gas Purchase Agreement.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

**SECTION 1.** The City Council of the City of Farmers Branch hereby authorizes the City Manager to negotiate and execute a First Amendment to the Landfill Gas Purchase Agreement in substantially the form attached hereto as Exhibit "A", and does further authorize the City Manager to negotiate and execute on behalf of the City all necessary contract documents and, subject to available funding, to execute any change orders, renewal options, amendments, or other instruments related thereto.

**SECTION 2.** This Resolution shall become effective immediately from and after its passage.
