RESOLUTION NO. 2025-173

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, ACCEPTING A BLUE CROSS AND BLUE SHIELD OF TEXAS – BLUE IMPACT GRANT IN THE AMOUNT OF \$60,000 TO BE USED TOWARDS THE CITY'S PARTICIPATION IN THE 2025 HEALTHY CITIES CAMPAIGN; AUTHORIZING CITY MANAGER OR DESIGNEE TO ADMINISTER GRANT FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in 2023, Blue Cross and Blue Shield of Texas launched the Blue Impact Grant Program to promote health and wellness through five key factors: economic opportunity and stability, nutrition, neighborhood and built environment, locally defined health solutions, and optimal health outcomes; and

WHEREAS, applied for the Blue Impact Grant Program to assist with the City's participation in the 2025 Healthy Cities Campaign; and

WHEREAS, Blue Cross and Blue Shield of Texas has awarded its highest Blue Impact Grant in the amount of \$60,000.00 to be used towards the City's participation in the 2025 Healthy Cities Campaign; and

WHEREAS, the City Council finds that it is in the best interest of the City to accept the grant and authorize the City Manager to administer the funds and enter into appropriate agreements to fulfill the purposes of the Healthy Cities Campaign.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

SECTION 1. The City Council hereby accepts the grant funds of \$60,000.00 (the Grant Funds) and directs the City Manager or their designee to allocate the funds to appropriate purposes that fulfill the purposes of the 2025 Healthy Cities Campaign.

SECTION 2. The City Manager, or their designee, is hereby authorized to execute on behalf of the City of Farmers Branch all contract documents and agreements necessary to accept the Grant Funds.

SECTION 3. The City Manager, or their designee, has full authority to administer the Grant Funds and associated programs on behalf of the City including, but not limited to, authorizing matching local funds, entering into agreements, and any other administrative tasks the City Manager may, from time to time, deem appropriate and necessary.

SECTION 4. This Resolution shall be effective immediately upon final passage.
