



## ORDINANCE NO. 3896

### AN ORDINANCE OF THE CITY OF FARMERS BRANCH, TEXAS, AMENDING THE FARMERS BRANCH CODE OF ORDINANCES, APPENDIX A “FEE SCHEDULE,” RELATING TO VARIOUS FEES ESTABLISHED PURSUANT TO CHAPTERS 18, 26, 56, AND 66 OF THE CODE OF ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the City Council of the City of Farmers Branch, Texas, finds it to be in the public interest to amend the City of Farmers Branch Code of Ordinances, Appendix A “Fee Schedule” and/or related sections of the Code of Ordinances in order to better reflect the cost of certain services provided by the City of Farmers Branch.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:**

**SECTION 1.** The Code of Ordinances of the City of Farmers Branch, Appendix A “Fee Schedule” shall be amended as follows:

- A. Appendix A, “Fee Schedule,” of the Code of Ordinances of the City of Farmers Branch, Texas, relating to fees to be charged as authorized by Chapter 18 “Animals” is amended by amending the fees as follows:

E. Appendix A, “Fee Schedule,” of the Code of Ordinances of the City of Farmers Branch, Texas, relating to Chapter 66 “Solid Waste” is amending in its entirety to read as follows:

	Chapter 66. Solid Waste	
66-43	Single family residence	\$5.00/month
	Single family residence occupied by a customer who provides documentation to the city establishing that the customer or customer’s spouse is 65 years of age or older, or those who collect Social Security Disability	\$2.50/month

**SECTION 2.** Should any sentence, paragraph, subdivision, clause, phrase or section of this Ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this Ordinance as a whole, or any part or provision thereof other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of the Code of Ordinances as a whole.

**SECTION 3.** This Ordinance shall be effective November 12, 2024, after final passage.
