STUDY SESSION ITEMS

C.1 Review and discuss Consent and Regular agenda items.

Councilmember Roman had questions on Item J.4 related to the purchase of police vehicles and requested to pull Item J.5 related to the City's application to the Texas Department of Transportation 2025 Transportation Alternatives Set-Aside Call for Projects from the Consent Agenda.

C.2 Discuss and review the Dallas County Replacement Housing Program.

Special Projects Manager Jose Garibay gave a presentation regarding the Dallas County Replacement Housing Program, explaining the background of the program, the City's projected milestones, the current City-owned lots, and the next steps in the process.

Council requested the following information:

- Councilmember Roman requested a list of homes that are owned by the City versus properties owned by applicants who want to stay in their homes.
- Councilmember Roman requested information about where residents can live during construction and if residents can choose the lot location.

The majority of Council directed to move forward with the 10 referenced lots in collaboration with the Builders of Hope.

Deputy Director of Planning Sarah Bergman gave a presentation explaining the background of the notification boundaries, the notification boundary of surrounding cities, and the proposed amendment to the ordinance.

The Council recommended the following:

- Deputy Mayor Pro Tem Neal recommended the Planning Department be flexible on notifications for hospitals, schools, and other entities that may be impacted by the zoning change.
- Councilmember Roman recommended the use of larger and more noticeable signage when posting a zoning change at a property.
