Н. **PUBLIC HEARING**

H.1 25-ZA-06 Conduct a public hearing and consider the request for a zoning amendment for industrial development on approximately 28 acres located at 2645 LBJ Freeway within Planned Development District No. 74 (PD-74); and take appropriate action.

Mr. Mangum gave a presentation regarding the proposed amendment.

Mr. Mangum answered questions and addressed comments from Commissioners regarding: the project phase graphic included in Mr. Mangum's presentation, previous zoning approvals for this site, total square footage for each building, a typo in the staff report regarding the date the Commission considered the previous zoning amendment related to the proposed development, clarification regarding the definitions of warehouse/distribution, light assembly, and light fabrication, traffic impact with the addition of a fourth warehouse building, whether the conditions recommended by the Commissioners from the previous amendment were included with this amendment, and the comprehensive plan recommendation for this site.

Hearing no further questions or comments from the Commissioners, Chair Raley opened the public hearing.

Kyle McCullah, 18383 Preston Road, Dallas, and Robert Dye, 13218 Bee Street, Farmers Branch, representatives for the applicant, answered questions and addressed comments from the Commissioners regarding: who the developer of the project was, proposed uses and potential future tenants for this development, whether the applicant had any signed leases the type of screening wall proposed between this site and Dallas Christian College (DCC), whether the applicant discussed the proposed wall with DCC, travel routes for large trucks entering and exiting this development, whether the applicant had acquired the Wyndham Garden hotel, and the demolition process for the hotel.

Hearing no further questions or comments from the Commissioners, Chair Raley asked for a motion to close the public hearing.

A motion was made by Vice-Chair Miller, seconded by Commissioner Kirby, that the public hearing be closed. The motion carried unanimously.
