



**RESOLUTION NO. 2019-012**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH ASHLAR CONTRACTING COMPANY FOR THE BROOKHAVEN COLLEGE CAMPUS-INTERCITY TRAIL CONNECTION PROJECT; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Texas Department of Transportation (TxDOT) has approved a Local Project Advance Funding Agreement (“AFA”) to provide funds for the construction of a pedestrian bridge over Farmers Branch Creek east of Marsh Lane, signalized protected crosswalk on Valley View Lane at Rosser Road intersection, in association with the Brookhaven College Campus-Intercity Trail Connection (the “Project”); and

**WHEREAS**, City Administration has received and reviewed four bids, has determined that Ashlar Contracting Company, has submitted the lowest most responsible bid, and recommends that the City enter into a contract with Ashlar Contracting Company for the Project; and

**WHEREAS**, the City Council of the City of Farmers Branch, Texas finds it to be in the public interest to accept the recommendation of the City Administration;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS THAT:**

**SECTION 1.** The City Manager is authorized to sign on behalf of the City a contract with Ashlar Contracting Company for the Project in the amount of \$613,333. City Manager is further authorized to sign such change orders to said contract as the City Manager deems reasonable, necessary, and in the public interest which are in compliance with applicable law and City Policy.

**SECTION 2.** The City Manager is further authorized to take such actions as may be necessary to perform the City’s obligations set forth in the AFA including providing the City’s matching funds in the amount of \$472,432 from current funds available in the City’s Budget for Fiscal Year 2018-2019.

**SECTION 3.** This Resolution shall become effective immediately upon its passage.
