



RESOLUTION NO. 2024-078

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, CANVASSING AND DECLARING THE RESULTS OF THE GENERAL ELECTION FOR COUNCILMEMBER - DISTRICT 3 AND COUNCILMEMBER – DISTRICT 5 HELD MAY 4, 2024; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, it is hereby found and determined that notice of the election was duly given in the form, manner, and time required by law, and said election was in all respects legally held and conducted in accordance with applicable laws of the State of Texas and the proceedings calling and governing the holding of such election; and

WHEREAS, it is imperative to consider the returns of an election held on the May 4, 2024, for the purpose of electing the hereinafter named officials; and,

WHEREAS, the returns of said election have been duly and legally made and submitted to the City Council for canvassing, and a tabulation of the returns for the polling place and for early voting, as canvassed and tabulated by this governing body as follows:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

SECTION 1. Said election was duly called, and notice of said election was given in accordance with law, and said election was held in accordance with the law, the following individual, **David Reid**, having run unopposed in said election for City Councilmember - District 3, is hereby declared to be duly elected to the office of Councilmember - District 3; and having received the majority of the votes cast in said election for City Councilmember - District 5, **Roger Neal** is declared to be duly elected to the office of Councilmember – District 5, subject to the taking of the oath of office as provided by the Constitution and laws of the State of Texas.

SECTION 2. Said election was duly called, notice of said election was given and held in accordance with law, the following individuals, having received the majority of votes cast in said

election, are hereby declared elected to the following offices, subject to taking the Oath of Office as provided by the Constitution and laws of the State of Texas.

- **David Reid, City Councilmember District 3**
- **Roger Neal, City Councilmember District 5**

SECTION 3. It is further found and determined that in accordance with the order of this governing body, the City Secretary posted written notice of the date, place and subject of this meeting on the bulletin board located in the City Hall, a place convenient and readily accessible to the general public, and said notice having been so posted and remaining posted continuously for at least 72 hours preceding the scheduled time of said meeting.

SECTION 4. This resolution shall become effective immediately from and after its passage.
