FY 2018-19 Work Program / Big Items for the Future

- Commission's work program aligns with Council Strategic Initiatives and Critical Business Outcomes for FY2018-19
 - IH-35 Corridor interim rezonings (*underway – estimated completion Apr.*)
 - Initiate IH-35 Corridor vision study (*Apr.-May*)
 - Update landscaping regulations (CZO) (*initiate March*)
 - Evaluate (and possibly amend) non-conforming properties regulations (CZO) (*initiate May*)
 - Update parking regulations (CZO) (*late summer*)

Other Items

- Additional action items (longer term)
(Council requested)
 - Determine strategy to address hotel uses throughout the city
 - Evaluate uses/items that require SUP to determine if that is the most appropriate means for regulating use/item
 - Propose code amendments related to quality multi-family standards
 - Propose code amendments regarding allowing alternate types of durable exterior building materials (residential and commercial)



Other Items

- Additional action items (longer term)
(P&Z Commission requested)
 - Consider alternate fence types (residential)
 - Receive presentation regarding approved bond items including general time line for implementing the bond related projects
 - Receive presentation from FB Police regarding potential safety measures for multi-family developments
 - Tour of various recently completed development projects, as well as new projects that may be under construction
