

RESOLUTION NO. 2025-225

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, REESTABLISHING A CHARTER REVIEW COMMITTEE; APPOINTING THE MEMBERS OF THE CHARTER REVIEW COMMITTEE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Farmers Branch finds it in the best interest of the City to reestablish a Charter Review Committee consisting of at least thirteen (13) members with at least two (2) members appointed from each City Council District, and up to at least two (2) members nominated by the Mayor, in accordance with the City Charter; and

WHEREAS, the City Council desires to appoint the members of the Charter Review Committee to review the City Charter for the purpose of making recommendations to the City Council for appropriate amendments to the City Charter, to be approved by the voters at an election to be called for May 1, 2027, for such purpose;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:
