## **RESOLUTION NO. 2025-190**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, AUTHORIZING AN AMENDMENT TO THE CITY'S 2023 AGREEMENT WITH AXON ENTERPRISES, INC. TO PURCHASE IN-CAR AUDIO/VIDEO RECORDING EQUIPMENT, BODY-WORN CAMERAS, AND TASERS FOR THE POLICE DEPARTMENT IN AN AMOUNT NOT TO EXCEED \$567,174.37; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, to comply with applicable state law as well as for the benefit of the health and safety of the City's residents and members of the Farmers Branch Police Department, the City has previously purchased and installed audio/video recording equipment in City police vehicles, bodyworn cameras and microphones to be worn by officers, and electronic control devices, aka Tasers (collectively the "Equipment") from Axon Enterprises, Inc.; and

**WHEREAS**, the City previously approved an agreement with Axon for the purchase of the Equipment via Resolution 2023-102 and

WHEREAS, Police Department administration has identified a need for additional Equipment for all current sworn personnel and squad cars, and has determined that the Equipment manufactured and sold by Axon continues to satisfy the required specifications and to provide the best value to the City and the Department, and recommends the purchase and installation of such additional Equipment through an amendment to the City's 2023 agreement with Axon; and

**WHEREAS**, Police Department administration has obtained a quote from Axon (Q-684112-45923JS), attached hereto as **Exhibit A**, for the additional Equipment and recommends accepting the quote and executing the amendment; and

**WHEREAS**, the City Council finds it to be in the public interest to approve the recommendation of the Police Department administration.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

**SECTION 1**. The City Council of the City of Farmers Branch authorizes the City Manager to execute an amendment to the City's 2023 agreement with Axon Enterprise, Inc. for law enforcement devices in an amount not to exceed \$567,174.37, a copy of which is attached to this Resolution as **Exhibit A**. The City Manager is further authorized to accept and approve such additional change orders and contract amendments as the City Manager deems reasonable, necessary, in the public interest, in compliance with applicable law and City policy, and, in the case of an increase in contract price, subject to the availability of funds.

**SECTION 2**. This Resolution shall become effective immediately upon its approval.
