RESOLUTION NO. 2025-164



A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, AUTHORIZING THE PURCHASE OF FLOCK SAFETY DRONE HARDWARE AND SERVICES FROM FLOCK GROUP INC. USING MVCPA GRANT FUNDS AND OTHER CITY BUDGETED FUNDS RELATED TO THE SAME; AUTHORIZING THE CITY MANAGER TO EXECUTE APPROPRIATE AGREEMENTS AND PROVIDE PAYMENT ON THE CITY'S BEHALF; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, under the provisions of the Texas Transportation Code Chapter 1006 and Texas Administrative Code Title 43; Part 3; Chapter 57, entities are eligible to receive grants from the Motor Vehicle Crime Prevention Authority to provide financial support to law enforcement agencies for economic motor vehicle theft and fraud-related motor vehicle crime enforcement teams; and

WHEREAS, on July 28, 2025, the Texas Motor Vehicle Crime Prevention Authority ("MVPCA") awarded the City of Farmers Branch (the "city") a grant under the Task Force Grant program for law enforcement agencies for motor vehicle theft detection, burglary from a motor vehicle and/or fraud-related motor vehicle crime, for \$240,000 with a City match amount of \$30,000; and

WHEREAS, the Farmers Branch Police Department recommends that the following equipment and services, as further identified in Exhibit "A", attached hereto, are necessary to conduct criminal investigations; and

WHEREAS, the Farmers Branch Police Department further recommends that the equipment and services identified in Exhibit "A" should be purchased with MVCPA Grant and other City funds previously budgeted for the Farmers Branch Police Department; and

WHEREAS, the City Council of the City of Farmers Branch, Texas, finds it to be in the public interest to approve the foregoing recommendations of the City Administration.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

SECTION 1. The City Council approves, and the City Manager is hereby authorized to accept and approve the purchase the equipment other services provided by Flock Safety, pursuant to the scope of work, purchase order, and other documents attached hereto as Exhibit "A" and Exhibit "B" (Farmers Branch Purchasing Rider), said purchase is to be paid using funds available in the MVCPA Grant other City funds previously budgeted for the Farmers Branch Police Department, and is further authorized to provide payment and to sign on the City's behalf any necessary or appropriate documents and accept and approve such contract amendments as the City Manager

deems reasonable, necessary, in the public interest, in compliance with applicable law and City policy, and, in the case of an increase in contract price, subject to the availability of funds.

SECTION 2. This Resolution shall take effect immediately upon its passage.
