A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, ON BEHALF OF THE FARMERS BRANCH FIRE DEPARTMENT AUTHORIZING THE CITY MANAGER TO EXECUTE AN INTERLOCAL COOPERATION AGREEMENT ("ILA") FOR AIRCRAFT RESCUE FIREFIGHTER TRAINING SERVICES; AUTHORIZING THE CITY MANANGER TO EXECUTE THE SAME; AUTHORIZING THE FARMERS BRANCH FIRE DEPARTMENT TO TAKE ANY ADDITIONAL ACTS NECESSARY TO CARRY OUT THE CITY'S OBLIGATIONS UNDER THE ILA; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Interlocal Cooperation Act, Texas Government Code, Chapter 791, as amended (the "Act") provides authority for local governments of the State of Texas to enter into interlocal agreements with each other and with local government corporations for the purpose of performing governmental functions and services as set forth in the Act; and

WHEREAS, the Dallas – Fort Worth International Airport Board (the "Board") operates a firefighting training facility at Dallas-Fort Worth International Airport, which utilizes state-of-the-art technology for live fire training and classroom training, and provides the facility and Texas-certified instructors to train qualified personnel of local fire departments; and

WHEREAS, the Farmers Branch Fire Department desires to enter into an agreement with the Board to receive aircraft rescue firefighter training services; and

WHEREAS, upon full review and consideration, the City Council desires to authorize the ILA, and the City Council finds that the terms and conditions thereof should be approved and that the City Manager, or designee, should be authorized to execute the Interlocal Agreement on behalf of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

SECTION 1. The above and foregoing premises and recitals are found to be true and correct and are incorporated herein and made part hereof for all purposes.

SECTION 2. This The City Manager is hereby authorized to execute on behalf of the City and the Fire Department an ILA with the Dallas – Fort Worth International Airport Board for firefighter training services, a copy of which is attached hereto as **Exhibit A**, and for the Fire Department take any additional acts to carry out the City's obligations under the ILA.

SECTION 3. This Resolution shall take effect immediately upon its passage.
