RESOLUTION NO. 2025-175

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, AUTHORIZING THE PURCHASE OF THIRTEEN (13) FLEET VEHICLES THROUGH THE BUYBOARD COOPERATIVE PURCHASING PROGRAM FOR A TOTAL AMOUNT NOT TO EXCEED \$1,424,688.23; AUTHORIZING THE CITY MANAGER TO EXECUTE THE APPROPRIATE AGREEMENT AND PROVIDE FOR PAYMENT ON THE CITY'S BEHALF; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, City staff has determined that the Police Department, Public Works Department, Fleet Service Department, and Facilities Department have vehicle needs justifying the purchase of new vehicles; and

WHEREAS, City staff has obtained quotes for the purchase of thirteen (13) vehicles based upon the needs of these departments through the BuyBoard Cooperative Purchasing Program under various contracts with Midway Trailers, MHC Kenworth, Rush Truck, Kirby Smith, Sam Pack, and as otherwise provided in Section 1 below; and

WHEREAS, funding for these purchases is available through the City's General Fund, Facilities Fund, Fleet Fund, and Utilities Fund.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

SECTION 1. The City Council hereby approves, and the City Manager is hereby authorized to accept and approve the purchase of the thirteen (13) vehicles specified below for the total purchase price of \$1,424,688.23, through the BuyBoard Cooperative Purchasing Program as provided herein, and is further authorized to provide for payment and to sign on the City's behalf any necessary or appropriate documents and accept and approve such contract amendments as the City Manager deems reasonable, necessary, in the public interest, in compliance with applicable law and City policy, and, in the case of an increase in contract price, subject to the availability of funds.
