



## **RESOLUTION NO. 2013-046**

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, AUTHORIZING A SYSTEM PURCHASE AGREEMENT WITH FORD AUDIO-VIDEO FOR THE PURCHASE AND INSTALLATION OF A REPLACEMENT COURT ROOM AUDIO/VISUAL SYSTEM, UTILIZING THE TEXAS MULTIPLE AWARD SCHEDULE (TXMAS); AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Farmers Branch, Texas, pursuant to the authority granted by Section 271.081 – 271.083 Local Government Code, V.T.C.A., desires to participate in the described purchasing programs of the State Catalog Purchase procedures for automated information systems; and

**WHEREAS**, having requested and reviewed the proposal in response to system failures, age and changes in technology, to meet the court of record requirements for audio recordings of trials and proceedings, with no viable repair options of the current system at the City of Farmers Branch Municipal Court Room, city staff have determined that the proposal provided by Ford Audio-Video, utilizing the TXMAS schedule was the most responsive and provided the best value for the City; and

**WHEREAS**, City Administration requested quotes utilizing the Texas Multiple Award Schedule (TXMAS) contract number TXMAS-8-58I030; and

**WHEREAS**, the Court Technology Fund/Municipal Court/Public Safety Special Revenue fund contains funding in an amount not to exceed \$70,000 available for the replacement Court Room Audio/Visual system; and

**WHEREAS**, the City Council of the City of Farmers Branch, Texas, finds it to be in the public interest to purchase the above described replacement court room audio/visual system.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS THAT:**

**SECTION 1.** The City Manager is hereby authorized to take such action as necessary to purchase a replacement Court Room Audio/Visual system from Ford Audio-Video utilizing the Texas Multiple Award Schedule (TXMAS) contract number TXMAS-8-58I030 in an amount not to exceed \$70,000.

**SECTION 2.** This Resolution shall take effect immediately upon its passage.
