- The Council may contact the City Attorney directly if the subject matter is deemed necessary (Deputy Mayor Pro Tem Neal)
- A Councilmember shall notify the City Manager prior to a meeting if they will be attending the meeting remotely and the circumstances for the Councilmember's remote attendance (Mayor Lynne and Councilmember Villafranca)
