



ORDINANCE NO. 3243

AN ORDINANCE OF THE CITY OF FARMERS BRANCH, TEXAS, AMENDING THE CODE OF ORDINANCES, CHAPTER 82 “TRAFFIC AND VEHICLES”, ARTICLE II “OPERATION OF VEHICLES”, DIVISION 6 “PARKING”, SECTION 82-95 “NO PARKING ZONES” BY ESTABLISHING NEW NO PARKING ZONES ON PORTIONS OF WILMINGTON DRIVE AND MOUNT VIEW DRIVE; CONTAINING A SAVINGS CLAUSE; CONTAINING A SEVERABILITY CLAUSE; REPEALING ALL CONFLICTING ORDINANCES; PROVIDING FOR A PENALTY OF FINE NOT TO EXCEED \$200; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Public Works Director, in order to increase the safety of the movement of traffic along the public thoroughfares of the City of Farmers Branch, is recommending the establishment of certain no parking zones along portions of Wilmington Drive and Mount View Drive; and

WHEREAS, the City Council of the City of Farmers Branch, Texas, finds it to be in the public interest to amend the Code of Ordinances of the City of Farmers Branch to establish the recommended “no parking zones”;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS:

SECTION 1. Code of Ordinances, Chapter 82, “Traffic and Vehicles,” Article II, “Operation of Vehicles,” Division 6, “Parking,” Section 82-95, “No Parking Zones,” is hereby amended by adding new no parking zones on Wilmington Drive and Mount View Drive to be as follows:

| <i>Street:</i> | <i>Description</i> | <i>Time of Day</i> |
|-------------------------|---|--------------------|
| Wilmington Drive | West side, from the northwest center point of the radius at its intersection with Mount View Drive to a distance of 62 feet north. | All times |
| Mount View Drive | North side, from the northwest center point of the radius at its intersection with Wilmington Drive to a distance of 64 feet west. | All times |

SECTION 2. All ordinances or parts thereof expressly in conflict with this ordinance are hereby repealed.

SECTION 3. Appropriate signs prohibiting parking at the places and during the times consistent with this Ordinance shall be installed and maintained.

SECTION 4. Any person violating any provision of this ordinance shall be deemed guilty of a misdemeanor and upon conviction shall be fined a sum not to exceed TWO HUNDRED DOLLARS (\$200.00).

SECTION 5. An offense committed before the effective date of this ordinance is governed by prior law and the provisions of the Code of Ordinances, as amended, in effect when the offense was committed and the former law is continued in effect for this purpose.

SECTION 6. If any section, paragraph, subdivision, clause, phrase or provision of this ordinance shall be judged to be invalid or unconstitutional by a court of competent jurisdiction, the same shall not affect the validity of this ordinance as a whole or any portion thereof other than the portion so decided to be invalid or unconstitutional.

SECTION 7. This ordinance shall take effect from and after its passage and the publication of the caption of said ordinance as the law and the City Charter in such cases provides.
