



## **RESOLUTION NO. 2015-046**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE ON BEHALF OF THE CITY AN AGREEMENT BY AND BETWEEN THE CITY OF FARMERS BRANCH, TEXAS, AND KNIGHT SECURITY SYSTEMS, LLC; PROVIDING FOR A REPEALING CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City Council has been presented with a proposed Agreement (herein the "Agreement") between the City of Farmers Branch and Knight Security Systems, LLC, for updating and relocating the current jail control and security system utilizing State of Texas Department of Information Resources Contract No. DIR-SDD-1725, and being further described in Exhibit "A" attached hereto; and

**WHEREAS**, upon full review and consideration of all matters related thereto, the City Council is of the opinion and finds that the City Manager should be authorized to negotiate and execute on behalf of the City an Agreement with Knight Security Systems, LLC.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:**

**SECTION 1.** The City Manager, or designee, is hereby authorized to negotiate and execute on behalf of the City an Agreement with Knight Security Systems, LLC, and to execute any amendments or instruments related thereto.

**SECTION 2.** All provisions of the resolutions of the City of Farmers Branch, Texas, in conflict with the provisions of this resolution be, and the same are hereby, repealed, and all other provisions not in conflict with the provisions of this resolution shall remain in full force and effect.

**SECTION 3.** Should any word, sentence, paragraph, subdivision, clause, phrase or section of this resolution be adjudged or held to be void or unconstitutional, the same shall not affect the validity of the remaining portions of said resolution which shall remain in full force and effect.

**SECTION 4.** This resolution shall become effective immediately from and after its passage.
