


Current Board Vacancy Policy Language

The current guidelines are listed below:

- Actively recruit twice per year (April May) and (November
 - December) to build an eligible applicant list that can roll to the next active appointment phase
- Council to review board vacancies when a combination of three vacancies on various boards, or two or more vacancies on one board
- Minimum of three applications received for each board vacancy before bringing to Council for consideration
