



RESOLUTION NO. 2025-202

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, AUTHORIZING AN AGREEMENT WITH LIFE SCAN FOR NFPA 1582 COMPLIANT WELLNESS AND FITNESS EXAMS FOR FIRE DEPARTMENT STAFF IN AN AMOUNT NOT TO EXCEED \$77,562.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, NFPA 1582 physicals are thorough exams and fitness evaluations for Fire Department personnel to ensure they are physically healthy and capable of performing duties; and

WHEREAS, Life Scan has been administering these exams in recent years and another agreement with them will provide continuity of care; and

WHEREAS, City Administration recommends authorizing an agreement with Life Scan to provide the City with ninety-three NFPA 1582 compliant wellness and fitness exams for the Fire Department staff, attached here as Exhibit “A”; and

WHEREAS, the City Council of the City of Farmers Branch, Texas finds it to be in the public interest to approve the recommendation of the City Administration.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

SECTION 1. The City Council of the City of Farmers Branch hereby authorizes an agreement with Life Scan for NFPA 1582 compliant wellness and fitness exams in the amount of \$77,562.00, attached here as Exhibit “A”, and does further authorize the City Manager to negotiate and execute on behalf of the City all necessary contract documents and, subject to available funding, to execute any change orders, renewal options, amendments, or other instruments related thereto.

SECTION 2. This Resolution shall become effective immediately from and after its passage.
