A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, CANVASSING AND DECLARING THE RESULTS OF THE MAY 10, 2014, GENERAL ELECTION FOR MAYOR AND COUNCILMEMBER - DISTRICT 2, AND SPECIAL LOCAL OPTION ELECTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, it is imperative to consider the returns of the general and special elections held on May 10, 2014, for the purpose of electing the hereinafter named officials and determining the results of the propositions placed before the qualified voters of the City; and

WHEREAS, the returns of the general election have been duly and legally made and submitted to the City Council for canvassing, and a tabulation of the returns for the polling places and for early voting, as canvassed and tabulated by this governing body as follows:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

SECTION 1. The General Election for the offices of Mayor and Councilmember - District 2 was duly called, that notice of said election was given in accordance with the law, and that said election was held in accordance with the law, and, no individual having received the majority of the votes cast in said election for the office of Mayor or the office of Councilmember - District 2 as required by City Charter and State Law, the Mayor shall call a runoff election for said offices in accordance with Ordinance No.3259 between the candidates having received the most votes and second most votes cast in said election, said candidates being as follows:

- A. For the office of Mayor: David Koch and Bob Phelps
- B. For the office of Councilmember District 2: Harold Froehlich and Luther Bernstein

SECTION 2. The Special Local Option Election was duly called, that notice of said election was given in accordance with law, that said election was held in accordance with law, and that it is determined that the foregoing Proposition 1 has been **approved** by the majority of the qualified voters voting at said election.

SECTION 3. It is further found and determined that in accordance with the order of this governing body, the City Secretary posted written notice of the date, place and subject of this meeting on the bulletin board located at City Hall, a place convenient and readily accessible to the general public, and said notice having been so posted and remaining posted continuously for at least 72 hours preceding the scheduled time of said meeting.

SECTION 4. This resolution shall become effective immediately from and after its passage.
