



RESOLUTION NO. 2013-047

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, AUTHORIZING A SYSTEM PURCHASE AGREEMENT WITH KNIGHT SECURITY SYSTEMS FOR THE PURCHASE AND INSTALLATION OF VIDEO SURVEILLANCE AND ACCESS CONTROL SYSTEM REPLACEMENTS AT THE RECREATION CENTER AND JUSTICE CENTER UTILIZING THE STATE OF TEXAS DEPARTMENT OF INFORMATION RESOURCES CONTRACT DIR-SDD-1725; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Farmers Branch, Texas, pursuant to the authority granted by Section 271.081 – 271.083 Local Government Code, V.T.C.A., desires to participate in the described purchasing programs of the State Catalog Purchase procedures for automated information systems; and

WHEREAS, having evaluated system failures issues, age and changes in technology, with no viable repair options of the current video surveillance and access control systems at the City of Farmers Branch Recreation Center and Justice Center, City staff have determined the proposals provided by Knight Security Systems was the most responsive and provided the best value for the City; and

WHEREAS, City Administration requested vendor quotes utilizing the State of Texas Department of Information Resources contract DIR-SDD-1725; and

WHEREAS, a fixed asset request in the amount of \$55,000 to replace the existing Recreation Center systems was submitted as part of the FY 2013-2014 budget process. The Fixed Asset fund for FY 2012-2013 fiscal year budget has a fund balance available for this project; and

WHEREAS, the Recreation Center system is now in partial failure, staff recommends expediting this upgrade using funds currently available in the fixed asset fund balance; and

WHEREAS, the Municipal Court/Public Safety Building Security special revenue fund contains funding in the amount of \$115,175 available for the Justice Center Video Surveillance and Access Control system; and

WHEREAS, City Administration has determined the proposals which meet specifications and best meets the needs of the City can be purchased from Knight Security Systems through the State of Texas Department of Information Resources contract DIR-SDD-1725 for an amount not to exceed \$170,175; and

WHEREAS, the City Council of the City of Farmers Branch, Texas, finds it to be in the public interest to purchase the above described video surveillance and access control systems as recommended.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS THAT:

SECTION 1. The City Manager is hereby authorized to take such action as necessary to purchase Recreation Center and Justice Center Video Surveillance and Access Control System Replacements from Knight Security Systems through the State of Texas Department of Information Resources contract DIR-SDD-1725 in an amount not to exceed \$170,175.

SECTION 2. This Resolution shall take effect immediately upon its passage.
