## **RESOLUTION NO. 2025-051**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, AUTHORIZING EXECUTION OF A SUPPLIES AND INSTALLATION CONTRACT WITH PARADIGM TRAFFIC SYSTEMS, INC. TO COMPLETE INSTALLATION OF THE 2024 SIGNAL HEAD REPLACEMENT PROJECT, INC.; AUTHORIZING THE CITY MANAGER TO EXECUTE APPROPRIATE AGREEMENTS AND PROVIDE FOR PAYMENT ON THE CITY'S BEHALF; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, on August 20, 2024, the City Council of Farmers Branch passed and adopted Resolution 2024-125 awarding a contract with Bean Electrical, Inc. for the City's 2024 Signal Head Replacement Project to replace signal heads at six (6) intersections per year; and

**WHEREAS**, part of the Bean Electrical, Inc. contract, the City is required to purchase supplies and perform portions of installation work for Bean Electrical, Inc.; and

**WHEREAS,** only two (2) companies provide traffic signal supplies regionally for the City's 2024, Paradigm Traffic Systems, Inc. and Consolidate Traffic Controls, Inc. ("CTC"); and

WHEREAS, the City Administration has determined that CTC's rates for the required supplies and installation under its HGACBuy (a Texas government-to-government cooperative purchasing system) quote is higher than Paradigm Traffic Systems, Inc.'s quote of \$55,304.00; and

WHEREAS, upon review of the quotes and proposals, City Administration recommends that the City be authorized to purchase the supplies and installation from Paradigm Traffic Systems, Inc. in an amount not to exceed \$55,304.00; and

**WHEREAS**, the City Council of the City of Farmers Branch finds it in the public interest to authorize the foregoing purchase of supplies and installation as recommended by City staff and authorizes the City Manager to execute such purchase orders and other documents necessary to effectuate the purchase.

## NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

**SECTION 1.** The City Manager, or his designee, is hereby authorized to purchase supplies and installation from Paradigm Traffic Systems, Inc. for FY24-25, for a total contract amount not to exceed \$55,304.00, pursuant to the purchase documents attached hereto as Exhibit "A," and is further authorized to execute any necessary or appropriate documents and approve such amendments thereto as the City Manager deems reasonable, necessary, in the public interest, and in compliance with applicable law and City policy, and, in the case of an increase in contract price, subject to the availability of funds.

**SECTION 2.** This Resolution shall be effective immediately upon final passage.
