A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, AMENDING THE PREVIOUSLY APPROVED SITE PLAN FOR LOT 1, BLOCK 1, HUTTON VALLEY DISTRIBUTION CENTER ADDITION, AN ADDITION TO THE CITY OF FARMERS BRANCH, DALLAS COUNTY, TEXAS (COMMONLY KNOWN AS 2005 VALLEY VIEW LANE), AND LOCATED IN PLANNED DEVELOPMENT NO. 77 (PD-77); AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the owner of the property described as Lot 1, Block 1, Hutton Valley Distribution Center Addition, an Addition to the City of Farmers Branch, Dallas County, Texas according to the plat filed at Volume No. 97188, Page 01712, Map Records, Dallas County, Texas (commonly known as 2005 Valley View Lane and referred to hereafter as "the Property"), which is located in Planned Development No. 77 ("PD-77"), has made application to amend the existing site plan for the Property in order to provide for additional off-street parking for employees and customers; and

WHEREAS, having received the recommendation of the Planning and Zoning Commission that the amended site plan and associated drawings should be approved as requested, the City Council of the City of Farmers Branch, in the exercise of the legislative discretion, has concluded that the requested amended site plan for the Property should be approved;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS THAT:

SECTION 1. The Detailed Site Plan for the Property is hereby amended in its entirety as shown on Exhibit "A," attached hereto and incorporated herein by reference.

SECTION 2. In addition to the development and use regulations of Planned Development No. 77 (PD-77) applicable to the Property, the Property shall be developed substantially in accordance with the Detailed Site Plan attached hereto as Exhibit "A."

SECTION 3. This resolution shall become effective immediately upon its approval.
