



RESOLUTION NO. 2026-063

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, APPROVING AND ADOPTING THE FARMERS BRANCH MANSKE LIBRARY POLICIES ATTACHED HERETO AS EXHIBIT “A,” ESTABLISHING POLICIES AND PROCEDURES APPLICABLE TO THE OPERATION OF THE FARMERS BRANCH MANSKE LIBRARY; PROVIDING A REPEALING CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Manske Library Board, in conjunction with City Administration, has reviewed and recommends amendments to the Farmers Branch Manske Library Policies, establishing revised policies and procedures regarding the operation of the Farmers Branch Manske Library; and

WHEREAS, upon review and consideration of the said policies, the Council finds and determines that the Farmers Branch Manske Library Policies should be adopted and applied, and are in the public’s best interest.

NOW THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

SECTION 1. The Farmers Branch Manske Library Policies, attached as Exhibit “A,” is hereby adopted and shall henceforth regulate the operations of the Farmers Branch Manske Library from and after the effective date of this resolution. Future amendments to the Farmers Branch Manske Library Policies adopted herein may be made by City administration with advice and recommendations of the Manske Library Board.

SECTION 2. All provisions of the resolutions of the City of Farmers Branch, Texas, in conflict with the provisions of this Resolution or prior policies of the Farmers Branch Manske Library be and are hereby repealed, and all other provisions not in conflict with the provisions of this Resolution shall remain in full force and effect.

SECTION 3. Should any word, sentence, paragraph, subdivision, clause, phrase or section of this Resolution or policies adopted herein be adjudged or held to be void or unconstitutional, the same shall not affect the validity of the remaining portions of said Resolution or policies which shall remain in full force and effect.

SECTION 4. This Resolution shall become effective immediately from and after its passage.
