C. PUBLIC HEARING

C.1 Consider adopting Ordinance No. 3228 for a Specific Use Permit allowing a detached accessory building greater than 120 square

feet in area, located at 3646 Janlyn Lane, and within the One-Family Residential District 3 (R-3) and take appropriate action.

Chairman Patterson opened the public hearing and read the following information into the record.

The subject property is a 10,023 square foot lot with an existing two story, single family home comprised of 3,582 square feet built in 1965. The applicant is requesting a Specific Use Permit to construct a detached accessory building approximately 224 square feet, located in the rear yard on the southeastern portion of the lot.

Article15 of the Comprehensive Zoning Ordinance dictates that a residential property is allowed to have an accessory building if it is less than 120 square feet in floor area by right. Accessory buildings that are larger than 120 square feet, requires a Specific Use Permit.

City staff recommends approval of the Specific Use Permit allowing an accessory building structure located 3646 Janlyn Lane as depicted on the proposed site plan.

Ms. Alexis Jackson, Senior Planner, came forward and gave a brief presentation. She stated that the accessory building or gazebo would be 16 feet wide, 14 feet long and 12 feet tall, totaling 224 square feet. The structure would be setback 3 feet from the property line and would be built on a concrete slab with a cedar roof that would compliment the home. Ms. Jackson stated that the eave of the accessory structure would be 18 inches from the property line. Ms. Jackson stated that 21 notices were mailed to surrounding property owners. City staff received two responses in favor of the request.

Chairman Patterson noted that the applicant was present and asked if they would like to present any additional information.

Mrs. Bertl stated that she was available to answer any questions.

Chairman Patterson asked if anyone in the audience wanted to speak regarding this request. There being none, he closed the public hearing.

Commissioner O'Quinn asked if there would be an outdoor kitchen or fire pit added to the structure.

Ms. Jackson stated that those items are not proposed, but the accessory structure will have electricity.

A motion was made by Commissioner O'Quinn, seconded by Commissioner Bingham, that this Specific Use Permit be recommended for approval. The motion carried by the following vote:
