



RESOLUTION NO. 2018-65

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE ON BEHALF OF THE CITY AN AGREEMENT WITH DSE HOCKEY CENTERS, LP, AND/OR ITS RELATED ENTITIES, FOR THE MANAGEMENT AND OPERATION OF AN OUTDOOR ICE RINK; PROVIDING FOR A REPEALING CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City desires to provide an outdoor ice rink for its citizens; and

WHEREAS, DSE Hockey Centers, LP, and/or its related entities, intends to provide, furnish, operate, and manage an outside ice rink for the City on a multi-year basis; and

WHEREAS, City will own the outdoor ice rink following the installation by DSE Hockey Centers, LP, and/or its related entities; and

WHEREAS, the City Council is of the opinion and finds that the City Manager should be authorized to negotiate and execute an agreement with DSE Hockey Centers, LP, and/or its related entities, on behalf of the City of Farmers Branch.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

SECTION 1. The City Manager, or designee, is hereby authorized to negotiate and execute on behalf of the City an agreement with DSE Hockey Centers, LP, and/or its related entities, for the provision, operation and management of an outdoor ice rink, and to execute any amendments or instruments related thereto.

SECTION 2. All provisions of the resolutions of the City of Farmers Branch, Texas, in conflict with the provisions of this Resolution be, and the same are hereby, repealed, and all other provisions not in conflict with the provisions of this Resolution shall remain in full force and effect.

SECTION 3. Should any word, sentence, paragraph, subdivision, clause, phrase or section of this Resolution be adjudged or held to be void or unconstitutional, the same shall not affect the validity of the remaining portions of said Resolution which shall remain in full force and effect.

SECTION 4. This Resolution shall become effective immediately from and after its passage.
