



**ORDINANCE NO. 3391**

**AN ORDINANCE OF THE CITY OF FARMERS BRANCH, TEXAS, APPROVING THE 2016 TAX ROLL CERTIFIED BY THE CHIEF APPRAISER OF THE DALLAS CENTRAL APPRAISAL DISTRICT AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, assessments and renditions of all taxable property in the City of Farmers Branch have been made for the year 2016 by the Chief Appraiser of the Dallas Central Appraisal District; and

**WHEREAS**, the City Council of the City of Farmers Branch finds it to be in the public interest to accept and approve the ad valorem tax roll certified by the Chief Appraiser of the Dallas Central Appraisal District for 2016.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:**
