A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, AWARDING A UNIT PRICE CONTRACT FOR THE PURCHASE AND INSTALLATION OF ORNAMENTAL DECORATIVE SIGNS AND POLES TO BRANDON INDUSTRIES, INC.; AUTHORIZING THE CITY MANAGER TO EXERCISE OPTIONS TO EXTEND THE AGREEMENT TERM; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the 2016-2017 Public Works operating budget includes funds for the purchase and installation of ornamental decorative street signs and poles; and

**WHEREAS**, Brandon Industries, Inc. is the sole source for the type of ornamental decorative street signs and poles the City has installed from prior years of installations; and

**WHEREAS**, in order to remain uniform with the style of ornamental decorative street signs and poles previously installed, City Administration recommends awarding a unit price contract for the purchase and installation of ornamental decorative signs and poles to Brandon Industries, Inc.; and

**WHEREAS**, the City Council of the City if Farmers Branch, Texas, finds it to be in the public interest to approve the foregoing recommendation of the City Administration.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS THAT:

**SECTION 1.** The City Manager is authorized to sign on behalf of the City a unit price contract with Brandon Industries, Inc. for the purchase and installation of ornamental decorative street signs and poles in accordance with the unit prices set forth in Exhibit "A," attached hereto and incorporated herein by reference, said purchase to be paid using funds available in the Public Works Operating Budget.

**SECTION 2**. The City Manager is hereby authorized to exercise the options to extend the term of the agreement approved pursuant to Section 1, above, based on the same unit prices set forth in Exhibit "A", hereto, upon a finding by the City Manager that such extension is in the best interest of the City, and, to the extent such purchases are for periods after the current fiscal year, funds are available in the City's budget for such purchases at the time the purchase is made.

**SECTION 3.** This Resolution shall become effective immediately upon its passage.
