## **ORDINANCE NO. 3425**



AN ORDINANCE OF THE CITY OF FARMERS BRANCH, TEXAS, AMENDING THE **COMPREHENSIVE** ZONING **ORDINANCE AND ZONING MAP OF THE CITY OF FARMERS** BRANCH, TEXAS, BY REPEALING ORDINANCE NO. 3078 GRANTING A SPECIFIC USE PERMIT FOR A GAS WELL **COMPRESSOR SITE ON A 1.645 ACRE TRACT LOCATED WEST** OF THE BURLINGTON NORTH RAILROAD AND **APPROXIMATELY 270 FEET NORTH OF INTERSTATE 635** WESTBOUND FRONTAGE ROAD AND WITHIN PLANNED **DEVELOPMENT 88 (PD-88) ZONING DISTRICT; PROVIDING A** SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Planning and Zoning Commission of the City of Farmers Branch and the governing body of the City of Farmers Branch, in compliance with the laws of the State of Texas and the ordinances of the City of Farmers Branch, have given requisite notice by publication and otherwise, and after holding due hearings and affording a full and fair hearing to all property owners generally and to all persons interested and situated in the affected area and in the vicinity thereof, the governing body, in the exercise of the legislative discretion, has concluded that the Comprehensive Zoning Ordinance and Zoning Map should be amended;

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

**SECTION 1.** The Comprehensive Zoning Ordinance and the Zoning Map of the City of Farmers Branch, Texas, be, and the same are hereby amended, by repealing Ordinance No. 3078 granting a Specific Use Permit for a Gas Well Site on a 1.645 acre tract located West of the Burlington North Railroad and approximately 270 feet North of Interstate 635 Westbound frontage road and within Planned Development 88 (PD-88) Zoning District more particularly described in Exhibit "A" of said Ordinance No. 3078 ("the Property"), and terminating all rights granted in said ordinance for use and development of the Property for a gas well compressor site.

**SECTION 2.** Should any sentence, paragraph, subdivision, clause, phrase or section of this Ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this Ordinance as a whole, or any part or provision thereof other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of the Comprehensive Zoning Ordinance as a whole.

**SECTION 3.** An offense committed before the effective date of this ordinance is governed by prior law and the provisions of the Comprehensive Zoning Ordinance, as amended, in effect when the offense was committed and the former law is continued in effect for this purpose.

**SECTION 4.** This Ordinance shall take effect immediately from and after its passage and the publication of the caption, as the law and charter in such case provide.
