



## RESOLUTION NO. 2017-071

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, CANVASSING AND DECLARING THE RESULTS OF THE MAY 6, 2017, GENERAL ELECTION FOR MAYOR AND COUNCILMEMBER - DISTRICT 2; AND TAKE APPROPRIATE ACTION.

**WHEREAS**, it is hereby found and determined that notices of a general and special election were duly given in the form, manner and time required by law, and said elections were in all respects legally held and conducted in accordance with applicable laws of the State of Texas and the proceedings calling and governing the holding of such elections; and

**WHEREAS**, it is imperative to consider the returns of the general and special elections held on May 6, 2017, for the purpose of electing the hereinafter named officials and determining the results placed before the qualified voters of the City; and

**WHEREAS**, the returns of the general election have been duly and legally made and submitted to the City Council for canvassing, and a tabulation of the returns for the polling places and for early voting, as canvassed and tabulated by this governing body as follows:

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:**

**SECTION 1.** The General Election for the offices of Mayor and Councilmember - District 2 was duly called, that notice of said election was given in accordance with the law, and that said election was held in accordance with the law, and that it is determined that Bronson Blackson being unopposed for District 2 is duly declared elected; and no individual having received the majority of the votes cast in said election for the office of Mayor as required by City Charter and State Law, the Mayor shall call a runoff election for said offices in accordance with Ordinance No. 3417 between the candidates having received the most votes and second most votes cast in said election, said candidates being as follows:

- A. For the office of Mayor: Robert Dye and Harold Froehlich

**SECTION 2.** It is further found and determined that in accordance with the order of this governing body, the City Secretary posted written notice of the date, place and subject of this meeting on the bulletin board located at City Hall, a place convenient and readily accessible to the general public, and said notice having been so posted and remaining posted continuously for at least 72 hours preceding the scheduled time of said meeting.

**SECTION 3.** This resolution shall become effective immediately from and after its passage.
