



RESOLUTION NO. 2018-03

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, AUTHORIZING THE PURCHASE OF TREADMILL EQUIPMENT FOR THE FARMERS BRANCH COMMUNITY RECREATION CENTER FROM TEAM MARATHON FITNESS THROUGH THE BUY BOARD COOPERATIVE PURCHASING AGREEMENT; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS RELATED THERETO; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, City Administration has identified the need to purchase eight (8) Precor 835 TRM Treadmills and eight (8) Precor Audio Entertainment Cap for the Farmers Branch Community Rec Center from Team Marathon Fitness in the amount not to exceed \$51,251.60; and

WHEREAS, the City Council of the City of Farmers Branch finds it to be in the public interest to concur in the foregoing recommendation;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

SECTION 1. The City Manager is hereby authorized to purchase on behalf of the City eight (8) Precor 835 TRM Treadmills and eight (8) Precor Audio Entertainment Cap for the Farmers Branch Community Recreation Center from Team Marathon Fitness through the City's cooperative purchasing agreement with Buy Board in an amount not to exceed \$51,251.60, in accordance with the Sales Proposal attached as Exhibit "A", and is further authorized to execute all documents related thereto on behalf of the City of Farmers Branch.

SECTION 2. This Resolution shall become effective immediately from and after its passage.
