### **RESOLUTION NO. 2018-70**



A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH KNIGHT SECURITY SYSTEMS, LLC FOR THE MAINTENANCE, SUPPORT AND MONITORING OF THE CITY'S PHYSICAL SECURITY SYSTEMS THROUGH STATE OF TEXAS DEPARTMENT OF INFORMATION RESOURCES CONTRACT NO. DIR-TSO-3430; AUTHORIZING CHANGE ORDERS SUBJECT TO AVAILABLE FUNDS; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** the City of Farmers Branch has previously contracted with Knight Security Systems, LLC ("Knight") for the purchase and installation of the City's security camera, access control, and burglar and fire alarm systems (collectively "the Systems"); and

**WHEREAS,** City Administration recommends that an agreement with Knight be negotiated and executed to maintain and provide technical support for the Systems pursuant to the City cooperative purchasing agreement with the State of Texas Department of Information Resources through Contract No. DIR-TSO-3430; and

**WHEREAS**, the City Council of the City of Farmers Branch, Texas, finds it to be in the public interest to concur in such recommendation and authorize such agreement.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS THAT:

**SECTION 1.** The City Manager is hereby authorized to negotiate an agreement with Knight Security Systems. LLC through the City's cooperative purchasing agreement with the State of Texas Department of Information Resources through Contract No. DIR-TSO-3430 with an initial term of five (5) years at a cost of \$78,162 per year.

**SECTION 2.** The City Manager is authorized to negotiate and execute such change orders to the agreement authorized pursuant to Section 1, above, as may be reasonable and necessary to provide for changes to the System during the term of said agreement, subject to applicable City policy, state law, and the availability of current funds.

**SECTION 3.** This Resolution shall take effect immediately upon its passage.
