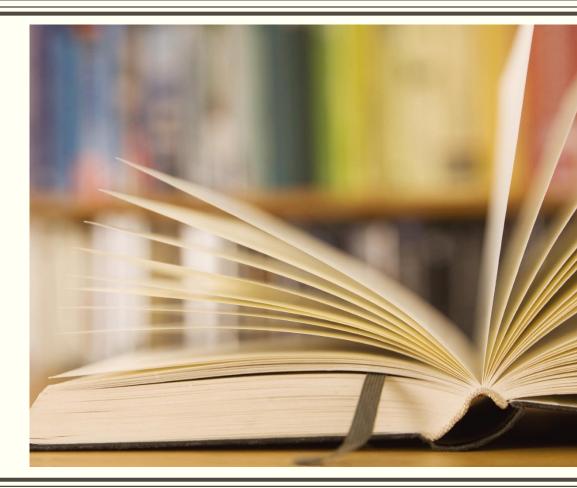

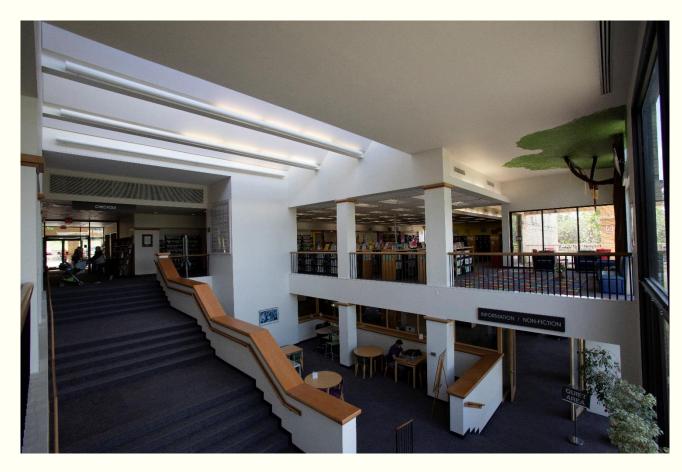
Vision

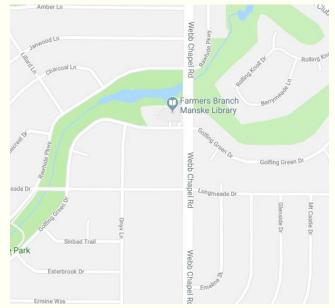

Why?

- City of Farmers Branch is invested in offering first-rate infrastructure and assets to achieve the city's potential (Guiding Principal #8)
- The library is consistently seen as value to the community; investing in the library is investing in all of us
- Public libraries support educational institutions giving all students NECESSARY access to supportive resources that may be absent in schools or homes
- The current building is outdated which impacts levels of service





Why Renovate?

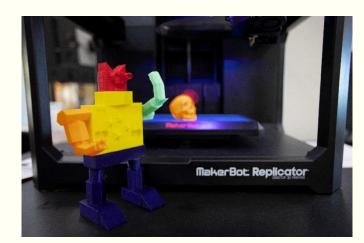
- The current location of the Manske Library offers ample square footage, beautiful scenery, and direct access to an expanding trail system
- The current location is perfectly and centrally located in Farmers Branch, and is in close proximity to the heavily residential part of the city and nearby schools
- This location is ideally situated to extend the library's offerings into outdoor spaces including ecological education, outdoor performances, and other venues
- Renovation has been recommended continuously by the library board since (at least) year 2000 and most recently by the Citizen's Bond Committee 2016
- Shows library patrons our commitment to respecting Manske Library's vision, history, and traditions; a renewed space for the community to be proud of

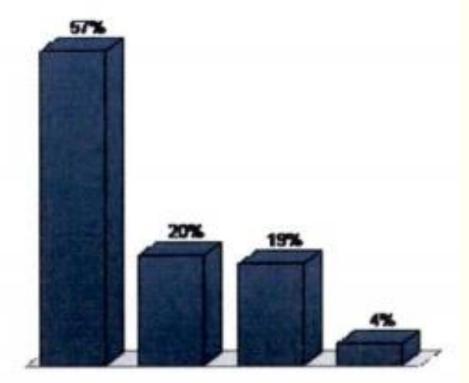

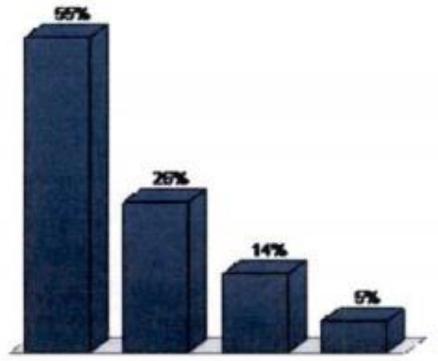
9. If technology is constantly changing and improving, do you feel a library should also be changing and improving to keep up? (Multiple Choice)

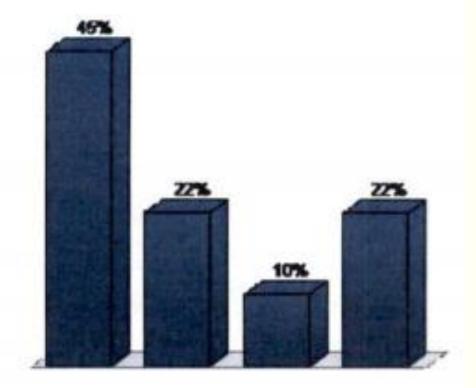
10. Would you support a plan to improve a library that has not seen major renovation in over 30 years? (Multiple Choice)

Master Plan in Fiscal Year 2000

- From March to September, consulting firm F. Mason & Associates collected data for the Library Master Plan.
- Input was gathered from:
 - Focus groups including businesses, educators, and seniors
 - An architectural charrette which allowed the public to offer ideas regarding a renovation and/or expansion.
 - A bilingual telephone survey with 402 respondents

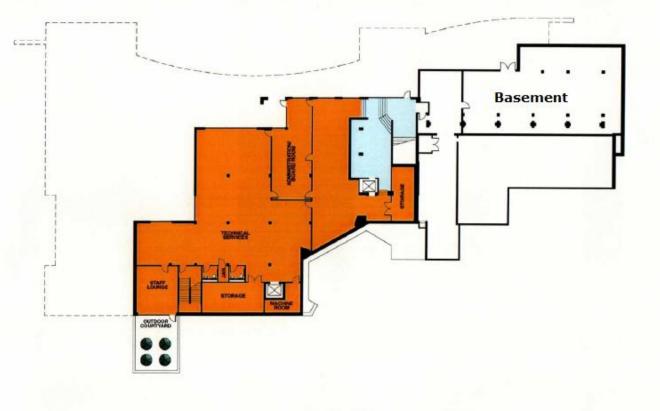
2004 presentation by Library Board to Council

Highlights of the Master Plan Fiscal Year 2000

Increase and expand the current Library building.

- Expand and reorganize the Library including reorganizing the children's area, expanding the teen/youth area, and improving and expanding staff work areas.
- Reorganize the Library space to allow all public services to be accommodated on one floor to improve efficiency, sightline management, and navigation for the public.
- Improve vehicular access and parking including providing drive-up book return and delivery functions.
- Add more signage and improve visibility.

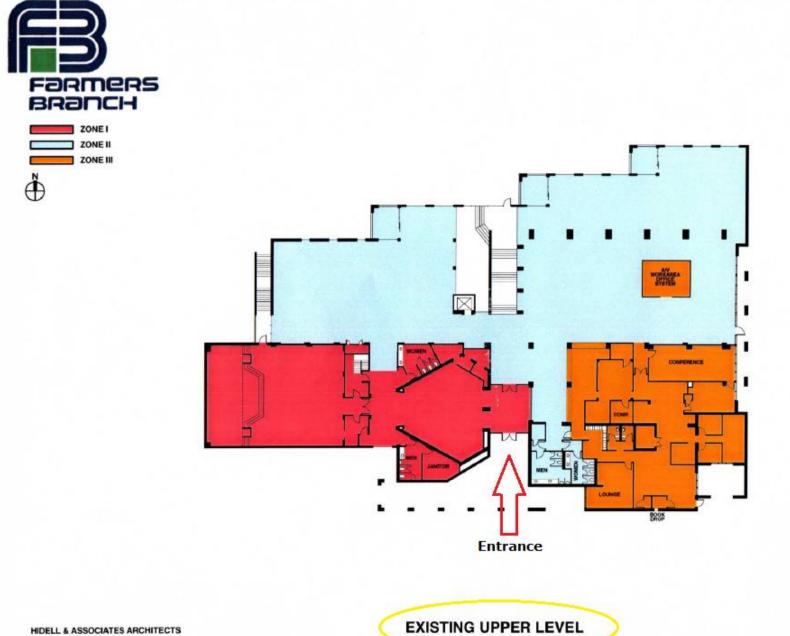


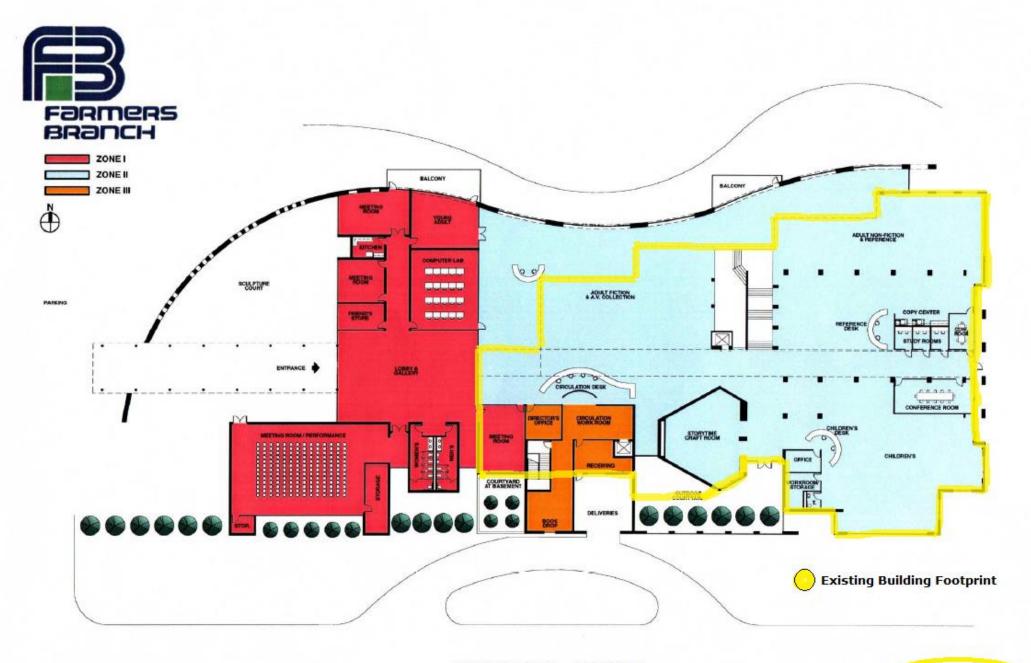

EXISTING LOWER LEVEL

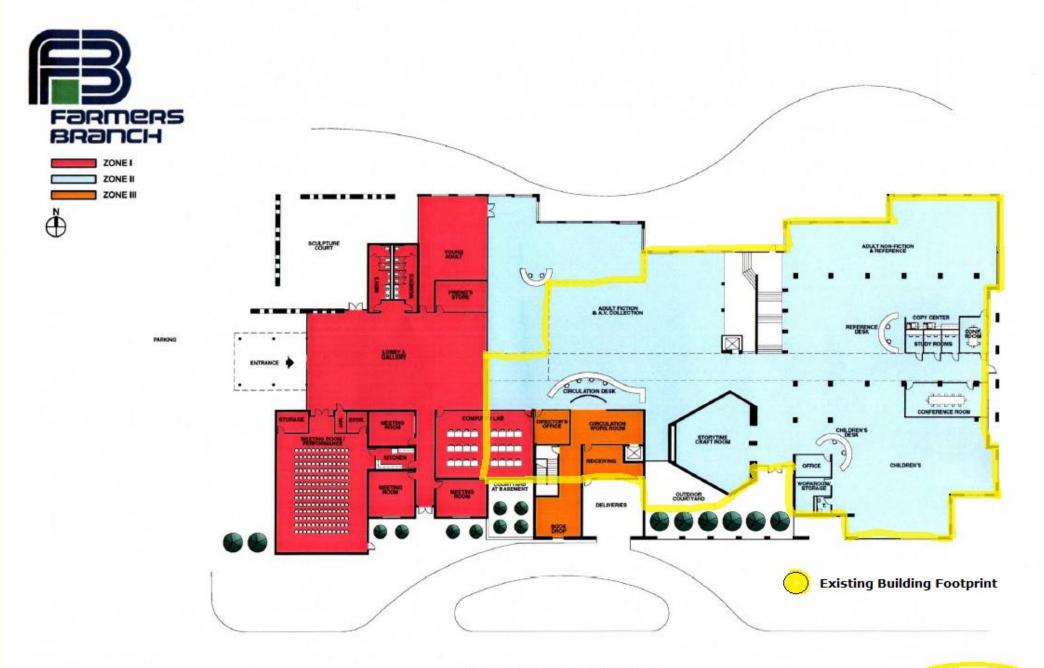

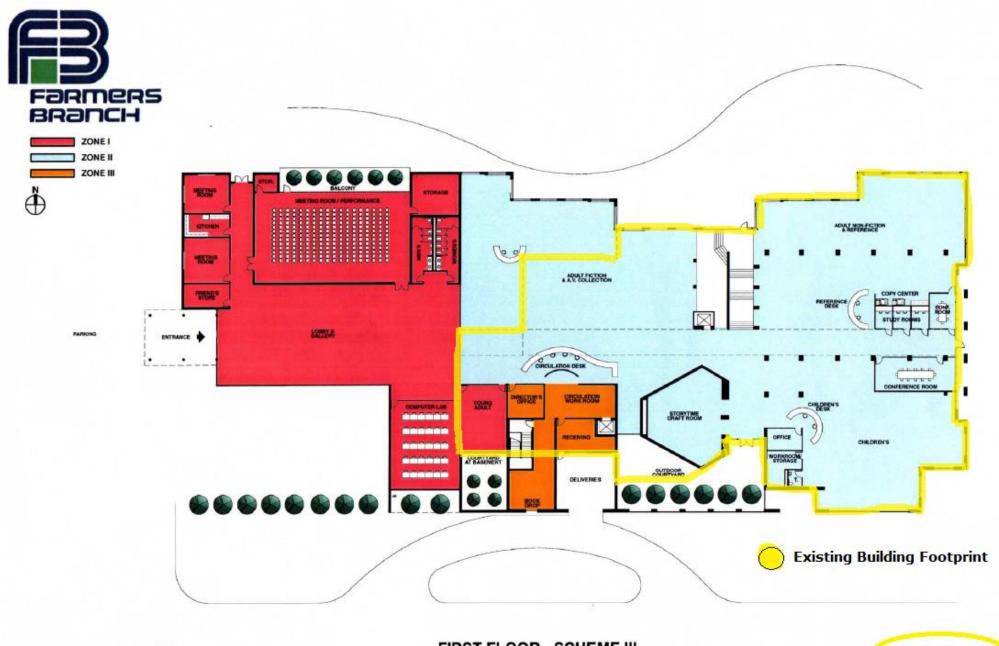


FIRST FLOOR - SCHEME I
