- **All proposed fees are generally comparable to those charged for similar services in neighboring cities and are necessary to defray the rising costs associated with providing these services.**






The proposed budget contains a water and sewer rate increase of 6%. These adjustments are included in revenue projections and are necessary to help offset increases by the Trinity River Authority for wastewater disposal and to maintain the financial stability of the Water & Sewer Fund. The monthly utility bill of an average residential customer with 6,000 gallons of water consumption, considering both the water and sewer rate change, will increase from \$73.20 to \$77.59 for a change of \$4.39 per month.
