

## CITY OF FARMERS BRANCH 2019 LEGISLATIVE PLATFORM

## Principle #1: Maintain municipal authority regarding local government revenue sources

- 1. Support legislation that would allow TMRS cities more options in regards to employee benefits.
- 2. Oppose legislation that limits local control and would enact a mandated reduction in the current ten-percent appraisal growth cap on residential property.
- 3. Oppose legislation that limits local control and would reduce the current eightpercent property tax roll-back rate or would require mandatory elections to increase the property tax rate.
- 4. Oppose legislation that limits local control and would impose a revenue cap of any type.
- 5. Oppose legislation that would result in the creation of unfunded mandates.
- 6. Oppose legislation that would impose a property tax freeze that can be implemented by any mechanism other than council action.
- 7. Oppose legislation that would enact sales tax exemptions that substantially erodes the sales tax base.
- 8. Oppose legislation that would not allow exemptions for "new growth" in the effective tax rate calculation.
- 9. Oppose legislation that would erode the ability of a city to issue debt.

## Principle #2: Maintain municipal authority over municipal land use issues

- Oppose legislation that would limit or remove the rights of Texas cities to control land uses, businesses, development, or environmental impacts that affects their land or citizens.
- 2. Oppose legislation that would erode municipal authority over rights-of-way or erode municipal authority to collect compensation for use of rights-of-way.
- 3. Oppose legislation that would erode the authority of cities to condemn property for a public purpose.
- 4. Oppose legislation that would restrict cities' ability to adopt or amend zoning regulations.
- 5. Oppose legislation that would erode municipal annexation authority.
- 6. Oppose legislation that would erode municipal authority to make amendments to model building codes.

- 7. Oppose legislation that would erode municipal authority to regulate the construction, location, placement, size, height, aesthetics, and landscaping of all residential structures.
- 8. Oppose legislation that would delete the requirement of utility companies to relocate their infrastructure at the request of cities.
- 9. Support legislation that would address the failure of utility companies to relocate their facilities in a timely manner as required by current law.

## Principle #3: Maintain municipal authority in determining how best to operate a city (local control)

- 1. Oppose legislation that would curtail economic development authority.
- 2. Oppose legislation that would erode the authority of a city to impose a civil penalty on the owner of a vehicle if the vehicle's license plate is photographed while the vehicle is running a red light.
- 3. Oppose legislation that would erode municipal sovereign immunity.
- 4. Oppose legislation that would limit or prohibit the authority of city officials to use municipal funds to communicate with legislators.
- 5. Oppose legislation that would reduce the number of uniform election dates.
- 6. Oppose legislation that would erode existing municipal authority relating to sex offender residency restrictions, or create state standards that preempts current or future municipal sex offender residency restrictions.
- 7. Oppose legislation that would limit management rights in employment matters.
- 8. Oppose legislation that would mandate employment benefit enhancements such as health insurance mandates.
- 9. Oppose legislation that would subject cities to statutes of limitations.
- 10. Oppose legislation that would restrict or limit indemnification clauses in construction contracts.
- 11. Support legislation that would allow municipalities the options of using a newspaper or an official website for the publication of official notices of the city.
- 12. Support legislation providing for the fair and representative design of voting districts.
