CITY OF FARMERS BRANCH NOTICE OF PUBLIC HEARING

ZONING CASE NO. 18-ZA-14

The City of Farmers Branch has received a request from David Martin (Windstead PC) to rezone approximately 32.3 acres located generally at the northeast corner of Webb Chapel Road and IH-635/LBJ Freeway and extending northward generally along Medical Parkway North and Myra Lane, from Planned Development No. 18 (PD-18) and One-family Residential District-6 (R-6) to Planned Development District No. 18 (PD-18), including amending the Planned Development No. 18 (PD-18) standards to allow, including but not limited to, one-family residential and independent living as additional permitted uses and establishing related development standards (see map on back).

The Planning and Zoning Commission will hold a public hearing to consider this request on **Monday, January 28, 2019 at 7:00 p.m.** The hearing will take place in the City Council Chambers of City Hall, located at 13000 William Dodson Parkway, City Hall Plaza, Farmers Branch, Texas.
