A. CALL TO ORDER – STUDY SESSION (3 P.M.) Mayor Dye opened the meeting at 3 p.m.

A.1 19–10 Discuss and review Boards and Commissions

City Secretary Amy Piukana provided a presentation showing the current standing board types, reviewed history, surrounding cities, and board updates to City Council.

After discussion, City Council agreed to make the orientation a requirement and replace members that are not in compliance during the regular appointments in June. This may entail a provision of automatic removal after a reasonable amount of time to complete required trainings. For appointments out of the norm, those members may watch a recording of the orientation under the supervision of the City Secretary to answer questions and validate training received.

In addition, City Council has directed to uniformly reduce boards in phases as terms expire to reach a membership of 7 regular members and 2 alternates for advisory boards except the Quasi-Judicial boards, Planning & Zoning Commission and Zoning Board of Adjustment.

Council agreed to receive biannual updates by the Sustainability Committee, Parks and Recreation Board, and Planning & Zoning (PZ) Commission with a joint meeting for PZ.

Council Member Blackson requested these changes be reflected and combined into Chapter 2, Article II of the Boards and Commissions chapter within the Code of Ordinances.

Deputy Mayor Pro Tem Bomgardner asked that subcommittees have a sunset provision, which allows automatic dissolution after the committee has completed tasks.
