



## ORDINANCE NO. 3592

**AN ORDINANCE OF THE CITY OF FARMERS BRANCH, TEXAS, AMENDING THE CODE OF ORDINANCES, CHAPTER 82 “TRAFFIC AND VEHICLES”, ARTICLE II “OPERATION OF VEHICLES”, DIVISION 6 “PARKING”, SECTION 82-95 “NO PARKING ZONES” BY ESTABLISHING NO PARKING ZONES ON PORTIONS OF THE WEST RIGHT OF WAY OF EAST BELTWOOD PARKWAY NORTH OF ITS EAST INTERSECTION WITH NORTH BELTWOOD PARKWAY TO THE NORTH CITY LIMIT LINE AND BY REPEALING THE NO PARKING ZONE ON HUTTON DRIVE BETWEEN VALLEY VIEW LANE AND ACADEMY LANE; CONTAINING A SAVINGS CLAUSE; CONTAINING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY OF FINE NOT TO EXCEED \$200; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City Administration, in order to increase the safety of the movement of traffic along the public thoroughfares of the City of Farmers Branch, is recommending eliminating the no parking zone on Hutton Drive between Valley View Lane and Academy Lane and establishing no parking zone along other portions of East Beltwood Parkway; and

**WHEREAS**, the City Council of the City of Farmers Branch, Texas, finds it to be in the public interest to amend the Code of Ordinances of the City of Farmers Branch to concur in the foregoing recommendation;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:**

**SECTION 1.** Code of Ordinances, Chapter 82, “Traffic and Vehicles,” Article II, “Operation of Vehicles,” Division 6, “Parking,” Section 82-95, “No Parking Zones,” is amended by adding the following No Parking Zone along the following segment of East Beltwood Parkway:

<i>Street:</i>	<i>Description</i>	<i>Time of Day</i>
East Beltwood Parkway	West side from its intersection with North Beltwood Parkway to the north city limit line.	All times

**SECTION 2.** Code of Ordinances, Chapter 82, “Traffic and Vehicles,” Article II, “Operation of Vehicles,” Division 6, “Parking,” Section 82-95, “No Parking Zones,” is amended by deleting and repealing the No Parking Zone along Hutton Drive between Valley View Lane and Academy Lane.

**SECTION 3.** Appropriate signs prohibiting parking at the places and during the times consistent with this Ordinance shall be installed and maintained by City forces.

**SECTION 4.** Any person violating any provision of this ordinance shall be deemed guilty of a misdemeanor and upon conviction shall be fined a sum not to exceed TWO HUNDRED DOLLARS (\$200.00).

**SECTION 5.** An offense committed before the effective date of this ordinance is governed by prior law and the provisions of the Code of Ordinances, as amended, in effect when the offense was committed, and the former law is continued in effect for this purpose.

**SECTION 6.** If any section, paragraph, subdivision, clause, phrase or provision of this ordinance shall be judged to be invalid or unconstitutional by a court of competent jurisdiction, the same shall not affect the validity of this ordinance as a whole or any portion thereof other than the portion so decided to be invalid or unconstitutional.

**SECTION 7.** This ordinance shall take effect from and after its passage and the publication of the caption of said ordinance as the law and the City Charter in such cases provides.
