## **ORDINANCE NO. 3600**

AN ORDINANCE OF THE CITY OF FARMERS BRANCH, TEXAS, AMENDING THE CITY'S 2018-2019 FISCAL YEAR OPERATING AND CAPITAL BUDGET; AMENDING PRIOR ACTS RELATING TO REPAYMENT OF CERTAIN FUND TRANSFERS; PROVIDING A REPEALING CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Farmers Branch, Texas Ordinance No. 3525 adopted a budget for the City for the fiscal year beginning October 1, 2018 and ending September 30, 2019 (the "Budget"); and

WHEREAS, the City Council of the City of Farmers Branch, Texas desires to amend the Budget;

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:

**SECTION 1.** The Budget of the City of Farmers Branch, Texas, for the fiscal year beginning October 1, 2018 and ending on September 30, 2019, as approved by Ordinance No. 3525, is hereby amended to conform with the Year-End Amended 2018-19 Budget as outlined in the attached schedule labeled Exhibit A and that all other provisions of the Budget not affected by the changes set forth in Exhibit A shall remain in full force and effect.

**SECTION 2.** The requirement set forth in the motion adopted by the City Council on July 23, 2019, to repay from Stormwater Utility Fund reserves the amount of \$1,086,000 transferred from the General Fund reserves to the Stormwater Utility Fund in accordance with said motion and as reflected in the amended Fiscal Year 2018-19 Budget is hereby repealed.

**SECTION 3.** All Ordinances of the City of Farmers Branch in conflict with the provisions of this Ordinance be, and the same are hereby, repealed and all other provisions of the Ordinances of the City of Farmers Branch not in conflict with the provisions of this Ordinance shall remain in full force and effect.

**SECTION 4.** Should any sentence, paragraph, subdivision, clause, phrase or section of this Ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this Ordinance as a whole or any part or provision thereof other than the part thereof decided to be unconstitutional, illegal or invalid.

**SECTION 5.** This Ordinance shall take effect immediately from and after its passage, as the law and City Charter in such cases provide.
