RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, APPROVING A PROFESSIONAL SERVICES AGREEMENT WITH KIMLEY-HORN AND ASSOCIATES, INC. RELATING TO THE SURVEYING AN PRELIMINARY DESIGN OF THE DENTON DRIVE TRAIL CONNECTOR PROJECT; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, City Administration and the City Council have determined that construction of a pedestrian trail system on the west side of the City will benefit the City's residents; and

WHEREAS, development of said trail system requires development of a trail connector from the southern city limits on Denton Drive continuing north to Rossford Street where the trail will connect to an existing public trail (the "Denton Drive Trail Connector Project"); and

WHEREAS, City Administration, having previously engaged the firm of Kimley-Horn and Associates, Inc. to provide professional engineering and survey services relating to the determination of the initial alignment of the Denton Drive Trail Connector Project, further finds said firm is qualified to perform the professional services necessary for the preparation of the preliminary design documents and related surveying services related to the Denton Drive Trail Connector Project and has negotiated an agreement with Kimley-Horn and Associates, Inc. to provide such professional engineering and survey services pursuant to costs for such services that are fair and reasonable; and

WHEREAS, City Administration recommends that an agreement with Kimley-Horn and Associates, Inc. be approved; and

WHEREAS, the City Council of the City of Farmers Branch, Texas, finds it to be in the public interest to concur in the above recommendation:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS THAT:

SECTION 1. The City Manager is authorized to negotiate and execute on behalf of the City an agreement with Kimley-Horn and Associates, Inc. for professional engineering and surveying services for the preparation of the Denton Drive Trail Connector Project in the amount of **\$61,900.00**. Furthermore, subject to applicable state law, city policies, and in the availability of funds in the City's budget for such purposes, the City Manager is authorized to agree to such additional services as he deems reasonable and necessary and in the best interest of the City.

SECTION 2. This resolution shall be effective immediately upon its approval.
