Division 1 –Redesign to bring scale house pad up to finish floor height. Transformer and metering requested by Owner.			
Division 2 – Demo 700lf of ¾" and 2" water line pipe. Scope of work is installing 940lf of 3", 300lf of 2½" and 440lf of 1½" water line. We also installed 8" water line crossing sanitary sewer at 2 separate locations. Lime stabilization required due to onsite native soils requiring additional processing under building slab to comply with structural engineer design parameters. Water pipe offsets around sewer GIS wasn't accurate.			
<u>Division 3 – Add concrete trench to accommodate pneumatic vacuum delivery systems to be provided by others. Scope of work includes design, engineering, supply and install of concrete, embedded angle and 1" plating.</u>			
<u>Division 8 – Deleted HVLS fans and changed overhead doors</u>			
<u>Division 15 – Modified sprinkler connections for changes caused by overhead doors</u>			
Division 16 – Electrical - Modifications made by utility provider (Coserv) original drawings depicting electrical transformer location dated 22 October 2018 prepared based on onsite visit with Coserv. Final Coserv design plans received dated 29 January 2019 depicting revised location extending electrical secondary approximately 220' to include (2) 4" underground conduits and a spare (1) 4" conduit and associated material.
